With a reference to UGC D.O. No. F.1-1/2021 (Secy) dated 16th July 2021 and directed that "in view of prevailing COVID-19 pandemic, admission process in Central Universities during Academic session 2021-22, may continue as per past practice". To consider the UGC Guidelines, the Indian Institute of Tourism and Travel Management (IITTM) revised their admission 2021 pattern. The revised guidelines as per UGC notifications for admission 2021 are mentioned below:

1. The candidate applied for BBA (TT) for the academic year 2021-24 may submit their self attested passed marksheets of class 10th, 11th and 12th and caste certificate for SC, ST and OBC Candidates (if applicable).
2. The candidate applied for MBA (TTM) for the academic year 2021-23 may submit their self attested passed marksheet of graduation and caste certificate for SC, ST and OBC Candidates (if applicable).
3. Those applicants who have not yet obtained their class 12th marksheet for BBA (TT) admissions and graduation marksheet for MBA (TTM) admissions may furnish a course completion certificate from the respective School/Board/College/University.
