The Indian Institute of Tourism and Travel Management (an autonomous body under Ministry of Tourism, Govt. of India), a multi campus institute, headquartered at Govindpuri, Gwalior, Madhya Pradesh - 474011 (hereinafter referred to as IITM), the First Party AND Jawaharlal Nehru University, New Mehrauli Road, New Delhi - 110067, (hereinafter referred to as JNU), the Second Party, both of them hereinafter singularly referred to as "the Party" and collectively referred to as "the Parties";

DESIRING to enhance understanding and excellence by promoting exchange and cooperation in the areas of academics, research, training and consultancy have agreed to institutional collaboration in education, through shared experiences, best practices and knowledge, with the primary objective to promote and strengthen the academic co-operation, aiming to enhance research, collaboration in national interest.

RECOGNISING the need to share value of academic cooperation and having agreed to further continue their common interests in promoting mutual cooperation in the area of academics and research activities at the IITM, headquartered at Gwalior, Madhya Pradesh;

PURSUANT to the prevailing laws and regulations;

HAVE reached the following understanding:

## ARTICLE 1

### Objective

The objective of this Memorandum of Understanding (hereinafter referred to as the "MoU") is to establish framework for cooperative institutional relations to encourage and promote cooperation in the area of academics, research mainly in tourism, travel and allied streams.

## ARTICLE 2

### Areas of co-operation

The Parties will endeavour to carry out the following exchanges and cooperative activities under this MoU:

1. The award of degrees of BBA, MBA and Ph.D. in Tourism and Allied Streams to the students of the Indian Institute of Tourism and Travel Management by the Second Party;
2. Exchange of best practices in the areas of academic, research, training, and consultancy.
3. Any other exchanges and cooperative activities that may be jointly decided upon by the Parties to further the objectives of this MoU.

## ARTICLE 3

### Implementation

1. The Parties shall hold periodical consultations as deemed necessary for implementing this MoU;
2. For implementation of this MoU, the Parties shall designate one nodal person, each, within one month of the entry into force of this MoU, to draw up the procedures, plans and recommend programmes of cooperation with a view to achieving the objectives of the MoU;
3. Specific details of procedures and programmes for exchange and cooperative activities will be decided in a manner to be separately agreed upon by the Parties;
4. This MoU may be amended at any time by written mutual consent of both the parties;
5. This MoU may be terminated by either party by the provision of written notice of termination not less than six months prior to the desired termination date. However, both parties agree that all continuing obligations to the students, staff, funding bodies or other entities shall be fully met with, subsequent to the notice of termination;
6. The termination of this MoU shall not affect the rights or obligations of either party regarding any binding offer of firm obligations approved and agreed to by either party prior to the termination date.

## ARTICLE 4

### Settlement of Differences

If any provision of this Memorandum is held by any court or other competent authority to be illegal, void or unenforceable in whole or in part, this MoU shall continue to be valid as to the other provisions thereof and the remainder of the affected provisions. Any differences arising out of the interpretation, application and implementation of this MoU shall be settled amicably through consultations and negotiations. However, in case the dispute remains unresolved it shall be referred to an Arbitrator to be appointed by mutual consent of both the parties, subject to the inclusive Jurisdiction of Civil Court at Delhi. The decision of the Arbitrator shall be final and binding upon both the parties.

## ARTICLE 5

### Amendment

This MoU can be reviewed or amended at any time by mutual written consent by the Parties. Such reviews or amendments shall enter into force on such date as may be determined by the Parties and shall form an integral part of this MoU.

## ARTICLE 6

### Entry into Force, Duration, and Termination

1. This MoU shall come into force for the period of 05 Year from the date of its signing. The MoU may further extended to the intended period upon mutual agreement of both the parties entered into agreement.
2. Either Party may terminate this MoU at any time by giving written notification at least six months prior to the intended date of termination;

3. The Termination of this MoU shall not affect the validity and duration of any on-going programmes or activities made prior to the termination of this MoU until the completion of such programmes or activities.






