ELIGIBILITY CRITERIA:

- 1. The bidder must possess the minimum qualification of B.Arch. from any recognized University in India. The employees working in the Architectural Firm should also possess the minimum qualification of B. Arch. with registration in Council of Architecture.
- 2. The bidder must have Architectural as well as Project Management capability, registration with competent and local authorities/ professional bodies for carrying out Architectural Consultancy services of this nature.
- 3. The bidder must have experience in this profession and must be authorized for taking up such consultancy works. Start Ups/ MSMEs will be given preference for promoting the flagship schemes of Government of India like 'Start Up India' and 'Atmanirbhar Bharat'.
- 4. The bidder must have successfully executed and completed at least one project of Tourism and Allied Sectors domain within the last 5 years.
- 5. The bidder must have minimum 10 numbers of highly qualified persons for campus planning, 3D visualization and various architectural consultancy services.
- 6. The bidder must have team member/s certified in green building and energy conservation.

7. Bidder's firm should have a team having very good quality of skills for the creation of 3D views, walk through, construction details designs, creation of working drawings, creation of PERT charts, phase wise Estimates of the projects like this Hotel Management Institute, Creation of structural drawings, submission drawings, etc. The bidder will be required to submit and present at least 25 slides covering above points during the Technical Presentation.

HOW TO APPLY:

The bidder is required to submit the proposal in two bid system i.e. (I) Technical Bid and (II) Financial bid respectively.

The separate bids envelopes should superscripting respectively as under:

- (I) Technical Bid
- (II) Financial Bid

The separate envelops in sealed cover shall be inserted in one single outer envelope superscripting - Bids for Architectural Services

The technical bid should also contain the following information:

- i. Technical Bid Submission Form
- ii. Firm's Profile
- iii. Firm's Experience
- iv. Firm's Staff Details
- v. Details of Firm's existing Clients
- vi. Details of the Projects Completed by the Firm
- vii. The hard copy of 25 slide Presentation showing quality expectations about architectural and technical skills of the Architects and Firms as discussed above.

The Financial bid should contain the following information:

- i. The financial quote of the firm for the services to be rendered.
- ii. The quote should be all inclusive.

TERMS AND CONDITIONS:

- The Architect/Firm is required to depute minimum two B. Arch. level resource person in the consultancy cell of IITTM for regular technical support. These resource persons will be finalized by IITTM authority on the basis of Interview and will be paid by the Firm finalized here. The resource persons should follow the timings of the institute and will coordinate the works related to the consultancy projects.
- 2. An Architect/Firm should possess the required knowledge and skill i.e. proficiency and competence to discharge the professional duties and required functions. An architect shall be required to comply with the standards of professional conduct and etiquette, as enforced by IITTM.
- 3. The Architect/Firm must exercise high level of skill and expertise while working in the assigned projects.

- 4. The Architect/Firm should make sure that there is no deficiency in its work while performing in the assigned projects.
- 5. An Architect/Firm is required to observe and uphold the Council of Architecture's Conditions of Engagement and Scale of Charges while rendering architectural services in terms of Regulation 2 (1) (xii) of the Architects (Professional Conduct) Regulations, 1989. Thus, failure to provide any service/services that is/are necessary for discharging his duties and functions for the project for which he has been engaged, shall amount to deficient service.
- 6. The payment shall be made by IITTM to successful bidder on satisfactory completion of the work, only after the funds are received from the sponsoring agency. The final decision of The Director, IITTM in this regard shall be binding on the successful bidder.
- 7. Earnest money Deposit of Rs. 15,000.00 submitted with the tender document, shall be accepted only in the form of demand draft drawn in favour of "Director, IITTM, Gwalior" drawn on any Nationalized Bank, payable at Gwalior.
- 8. The duration of agreement shall be operative till the project is completed.
- 9. In the event of breach of any of the terms and conditions mentioned in the agreement or in case the successful bidder is found involved in any of illegal or inappropriate activities, the agreement shall be terminated forthwith and the contract shall be dissolved. An appropriate legal action will also be taken as decided by the Director IITTM.
- 10. The architect/firm shall be liable to give minimum two months notice in writing for cancelling the contract before completion of the project. The Director IITTM reserves the rights to cancel the contract at any time without any prior notice or the reason thereof.
- 11. In case of any conflict or dispute arising between both the parties, it will be within the jurisdiction of the Courts at Gwalior only.

EVALUATION CRITERIA OF TECHNICAL AND FINANCIAL BIDS

The following procedure shall be adopted in evaluating the proposals:

1. The bidder should score at least 75% of total marks prescribed in the evaluation of technical bids to qualify for participation in the evaluation of financial bids.

ST = Total Technical Score

TP = marks obtained out of maximum 70 against Technical Presentation.

TS = marks obtained out of maximum 30 against Technical Bid.
