## **MBA (TOURISM & TRAVEL MANAGEMENT)**

The two-year full-time Master of Business Administration (Tourism & Travel Management) degree (as per the MoU signed under the collaborative scheme of Jawaharlal Nehru University, New Delhi-Ministry of HRD, Govt. of India) is offered for learners to enable them to acquire the suitable skill set with ample flexibility to adapt to employing the organization's needs. The academic year of the degree is comprised of one year with two semesters each.

The curriculum of the course is so modeled that the student has nurtured for the requirements of the industry as well as academia. Along with the core subjects like economics, management, etc. Students are also given the option of doing specialization like tour guiding, event management, and adventure tourism and also the option of studying supply chain and logistics. The course also comprises a portion of summer internships where they get the opportunity to an interface with the latest trends in the industry.

The fourth semester of the course comprises of On-the-Job Training (OJT) which is facilitated through campus interviews every year. In order to understand the nitty-gritty involved in the industry students are taken for a study tour mostly to a well-known tourist destination across the country.

### **GRADE POINT REQUIREMENTS/MINIMUM STANDARD**

A participant joining the programme semester-wise will be required to maintain a SGPA of 4.00 at the end of each semester.

A participant, in order to be eligible for the award of MBA degree, must have:

- (a) passed all the semesters / prescribed courses as laid down
- (b) he/she has obtained a CGPA of 4.00 at the end of the program.

- ❖ The end semester examination shall be conducted by the Institute under the overall guidance of the Competent Authority of the Institute within the dates specified by the University.
- ❖ The final results at the end of the program and award of MBA degree would be forwarded by the Director of the Institute and would be approved by the Vice-Chancellor before being announced.

## RESERVATION:

Reservation (for Indian Nationals) will be applicable per central government guidelines, i.e. 7.5% for S.T., 15% for SC, 27% for OBC (under the non-creamy layer) and 10% for EWS candidates. In all the available seats, a 3% horizontal reservation shall also be applicable for physically disabled candidates for admission to MBA (Tourism & Travel Management) 2026-28. Physically disabled candidates are strongly encouraged to apply.

**Note:**

1. The candidate from SC / ST / OBC / PWD must produce the valid category certificate issued by the competent authority. The OBC candidate must produce a non-creamy layer certificate per central Govt. regulations and issued by the competent authority within the last three years (please refer to Annexure A).
2. If the seats reserved for SC/ST remain vacant, then the same will be filled by the SC/ST candidates who appear for the entrance exam, irrespective of their ranking in the exam.

## AGE LIMIT:

**There is no age bar for pursuing MBA (TTM) for any category.**

## ELIGIBILITY FOR ADMISSION:

- 1) Possess a **Bachelor's Degree** in any stream from a recognized Indian or Foreign University (as per the AIU foreign equivalence list).  
Candidates appearing in the final year examination of graduation are also eligible to apply, **subject until they must submit their result of graduation by September 30, 2026, failing which their admission will be cancelled and the course fee deposited in the Institute will also be forfeited.** (In this regard, the student must submit an affidavit on non-judicial stamp paper of Rs.100/-).
- 2) Appear in the written "**IITM Admission Test (IIAT)**" to be conducted by IITM. The admission Test (AT) will be held on **Sunday, April 19, 2026 (tentative) from 10:00 am to 12:00 pm** through online/offline/hybrid mode.

The **final date of IITM Admission Test (IIAT)** will be notified later through the IITM website, email, and telecommunication.

**Exam will be on the pattern of MCQ of 100 questions /100 marks [General Awareness (50 Marks), Verbal ability (25 Marks) and Quantitative ability (25 marks)]. One mark for each correct answer and no negative marking for the wrong answer.**

## SELECTION PROCESS:

A candidate to be considered for admission in MBA (TTM) 2026-28 would have to participate in all three components of the screening process, as mentioned below. If the candidate does not appear in one of the components of the screening process, it will not include in the merit list. The admission in MBA (TTM) 2026-28 would be strictly based on the **overall performance of written test + Counselling cum G.D. & P.I.**, as given below:

**Inter-se-merit will be determined based on the above out of a maximum of 100 marks by moderating the written test score into 70% of the total marks obtained by the candidate, as practiced by the Institute.**

- a. In case two or more candidates have scored equal marks, the inter-se-merit of such candidates shall be determined based on higher scores and thereafter older in age.
- b. If the candidate fails to establish eligibility by **September 30, 2026**, the admission will be cancelled, and fees will be forfeited.

**Note:**

1. Students would be required to deposit academic and hostel fees semester-wise in their respective IITM centre by the schedule of deposit, failing which the student will have to pay a late fee as decided by the authority under the rules of the Institute or further disciplinary action may be taken by the Institute.
2. Programme related fee and other relevant fee will be charged separately.
3. The hostel fee must be paid separately to the respective IITM centre and applies only to students whom the *Institute allots hostel*.

The caution money (Rs. 1000/-) deposit at the time of admission is refundable to the student after completing their MBA (TTM) 2026-28 course after the production of the No Dues Certificate (NDC) and receipt of fees.

## IMPORTANT POINTS

1. The Institute shall not be responsible for any postal / courier delays in correspondence related to the admission process.
2. Candidates admitted to the programme in the merit list and who cannot get admission to the programme of their first choice shall be placed on a waiting list. Movements through waiting lists are strictly based on merit.
3. Once a candidate has been admitted to one of the programmes of IITM at any of the centres and his / her name is forwarded to JNU, his / her admission shall not be transferred to any other programme of the Institute.
4. Admission to the hostel is purely on a merit basis and the availability of accommodation in it.
5. A candidate/guardian must declare ailment and any medical history at admission.
6. Students, upon admission, shall be deemed to have agreed to abide by the rules and regulations of the Institute, hostel, examination, etc.
7. All matters are to be settled subject to the jurisdiction of the Madhya Pradesh High Court - Gwalior Bench.

## HOSTEL AND MESS FEE

The campuses offer limited hostel facilities to students at a very affordable price (*though a hostel room is not guaranteed*). Hostel rentals and mess fee are centre specific. The mess fee, caution money deposit and electricity charges are separate from the monthly hostel fee.

## SCHOLARSHIP

Students of IITM can avail of **Government Scholarships** offered by various agencies to students of different categories. The Central Govt. and State Governments are providing the scholarship (refund of tuition fee) to students belonging to OBC, SC, S.T., P.H. and minorities. Approximately 150 students benefit from these scholarships in every academic session. ## REFUND POLICY

The refund policy is applicable per the guidelines of UGC / JNU, New Delhi:

- The candidate who has been provisionally admitted may cancel admission by submitting an application for cancellation in duplicate and may request a refund of the fee within the prescribed date.
- If the online portal fails to detect the non-eligible applicant, then the responsibility lies with the applicant. So, the applicant needs to ensure their eligibility before applying for Admissions 2026.
- As applicable, the fee shall be refunded in due course. It is clear that such cancellation application will be considered if and only if the admission is confirmed by paying the prescribed course fee in full and by submitting the original documents.
- Refund shall be made as under:

If the request is received 15 days or more before the formally notified last date of admission.	100%
If the request is received less than 15 days before the formally notified last date of admission	90%
If the request is received 15 days or less after the formally notified last date of admission.	80%
If the request is received 30 days or less, but more than 15 days after formally notified last date of admission.	50%
If the request is received more than 30 days after the formally notified last date of admission.	0%

**FOR ALL ELIGIBLE REFUNDS, THE INSTITUTION SHOULD DEDUCT RS. 6,000 AS PROCESSING FEE.**

***Refund of Hostel & Mess charges is on pro-rata basis after deduction of user charges after vacate the hostel premises, excluding hostel admission fees.***

**Note:** 1. The commencement date of the academic season 2026-28 is June 30, 2026, and it will count for all purposes of refunding fee cases.  
2. All refund cases will be settled in **October 2026**.

## FACILITIES AT IITTM

IITTM centres have state-of-the-art infrastructure that supports a learning environment. Some of the variant features are as follows:

- All the classrooms have air-conditioner facilities and are well-equipped with state-of-the-art technology like projectors, LED Display and Smart classrooms.
- All the campuses have Wi-Fi facilities around the clock.
  - **Gwalior** campus is having hostel facility, auditorium, *ardh vrat* (mini-open auditorium), gym facility, conference room, computer lab, one of the best libraries of tourism in the country (Digitally modernized), canteen, lush green garden, indoor sports complex, open auditorium (under constructed), hostel mess, medical facilities, outdoor sports facilities like cricket cum football ground with night light facility, badminton court, basketball court and indoor sports facilities like billiard tables, table tennis, chess, carrom board, boxing punching bag, etc.
  - **Bhubaneswar** campus offers a well-equipped and student-centric learning environment with comprehensive residential and academic facilities. Separate on-campus hostel accommodation for boys and girls ensures safety, comfort, and convenience for students. The campus is supported by a hostel mess providing hygienic and nutritious meals, along with basic medical facilities for students' wellbeing. Academic and professional needs are met through a modern computer laboratory, a resource-rich library, and well-designed conference and seminar rooms to support learning, research, training programmes, and academic interactions. A gymnasium is available to promote physical fitness and a healthy lifestyle. The campus also encourages sports and recreation through a range of outdoor sports facilities, including cricket, badminton, and football, as well as indoor games such as table tennis, chess, and carrom board, fostering teamwork, discipline, and holistic development among students.
  - **Noida** campus is surrounded by a pleasing atmosphere, and it has a hostel facility, gym facility, conference room, computer labs, library, canteen, hostel mess, medical facilities, sports facilities etc.
  - **Nellore** campus is situated in the lap of nature near coastal areas and has a hostel facility, conference room, computer lab, library, canteen, medical facilities, sports facilities etc.
  - **NIWS IITTM Goa** is located in the Capital City, Panjim of Goa. Besides the MBA, the campus offers Watersports Courses. The Institute has a beautiful view of Caranzalem Beach from its premises, and the Dona Paula Jetty Point is just a walking distance from the campus. The campus has hostel facilities, a library, well-furnished classrooms with audio-visual aids, an auditorium, a boat house, a Watersports training area and an Olympic-sized Swimming Pool. The campus's pristine weather and clear sky provide an opportunity to do Star-gazing and photography.

3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, torment or embarrassment to adversely affect the physique or psyche of such fresher or any other student.
4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
7. Any act of physical abuse, including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
8. Any act or abuse by spoken words, emails, posts, or public insults would also derive perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.
10. Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the grounds of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.
