1. About the Project

IITTM has been entrusted by the Ministry of Tourism, Government of India, with an independent impact assessment of tourism interventions undertaken by the Ministry of Tourism, the Varanasi Development Authority, and the Government of Uttar Pradesh in Varanasi (Kashi-Sarnath). The study covers eighteen identified tourist locations and seven stakeholder categories - domestic and international tourists, local residents and community members, tourism service providers, street vendors and informal sector participants, government officials and local administration, representatives of cultural and heritage institutions, and other relevant respondents across visitor experience, infrastructure, livelihoods, digital adoption, branding, and sustainability.

This is a highly time-bound, high-stakes research assignment directly commissioned by the Ministry of Tourism against fixed, Ministry-reviewed milestones. Applicants should apply only if they are able to commit fully to an intensive field and reporting schedule for the entire contract period.

4. Working knowledge of quantitative and qualitative research tools, data analysis, and data visualisation.
5. Willingness to be based in Varanasi for the duration of fieldwork, including sustained stay for data collection, focus group discussions, and key informant interviews, and to shuttle between Noida and Varanasi as required by the project schedule.

4. Desirable

- Prior research experience working on survey-based research, impact assessment, or social/development-sector research projects on a Ministry of Tourism, State Tourism Department, or other government-sponsored destination assessment or development-sector research project.
- Prior residence in or extended familiarity with Varanasi/Sarnath.

5. Key Responsibilities

- Administer survey instruments across tourists, residents, service providers, vendors, government officials, and cultural/heritage institution representatives at the eighteen identified locations in Varanasi.
- Coordinate field enumerators and manage day-to-day field logistics and scheduling in Varanasi.
- Undertake geo-tagged, time-stamped photographic documentation to support the before-after assessment.
- Maintain the field diary, data logs, and data quality protocols.
- Carry out data entry, validation, and support transcription of qualitative material.
- Coordinate and support the conduct of focus group discussions and key informant interviews.
- Contribute to the drafting of the Inception, Interim, Draft, and Final Reports.

6. Terms and Conditions

(i) The engagement is purely contractual and co-terminus with the project. It confers no right or claims to regular employment in IITTM.
